RESOLUTION NO. R16-075

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF HILLSBOROUGH COUNTY, FLORIDA, TRANSMITTING AN AMENDMENT TO THE FUTURE OF HILLSBOROUGH COMPREHENSIVE PLAN FOR UNINCORPORATED HILLSBOROUGH COUNTY, AS ADOPTED BY ORDINANCE 89-28, AS AMENDED, CHANGING THE MAPS OF THE PLAN.

Upon motion by Commissioner Murman, seconded by Commissioner Higginbotham, the following resolution was adopted by a vote of 4 to 0.

WHEREAS, the Hillsborough County Board of County Commissioners adopted a comprehensive plan for Unincorporated Hillsborough County entitled *Future of Hillsborough Comprehensive Plan for Unincorporated Hillsborough County* on July 12, 1989 by Ordinance 89-28 (the "Comprehensive Plan"); and

WHEREAS, Section 163.3184, Florida Statutes, provides for a process for adoption of amendments to comprehensive plans; and

WHEREAS, following a public hearing held on April 11, 2016, to consider the proposed amendment to the Comprehensive Plan, the Hillsborough County City-County Planning Commission recommended approval of the proposed amendment; and

WHEREAS, pursuant to Section 163.3184, Florida Statutes, the Hillsborough County Board of County Commissioners considered at a public hearing held on June 16, 2016, the proposed amendment to the Comprehensive Plan summarized below:

WHEREAS, Section 163.3184, Florida Statutes, provides that the local government shall, following an advertised public hearing, transmit by affirmative vote of not less than a majority of the members of the governing body present at the hearing, a proposed comprehensive plan amendment to the applicable reviewing agencies and local governments.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF HILLSBOROUGH COUNTY, FLORIDA, AT A PUBLIC HEARING HELD THIS 16TH DAY OF JUNE, 2016:

1. That the Board of County Commissioners of Hillsborough County, Florida, hereby transmits to the applicable reviewing agencies, local governments and local governmental agencies as prescribed by Section 163.3184, Florida Statutes, the above-described proposed amendment to the Comprehensive Plan along with supporting data and analyses.

2. That this resolution shall take effect immediately upon adoption.
